## QUALIFYING SHAREHOLDING

Under the terms and for the purposes of article 17 of the Portuguese Securities Code, we hereby publish that Votorantim, notified us of the following:

"Under de terms set in article 16 of the Portuguese Securities Code ("CVM"), Votorantim Cimentos, S.A. a company incorporated under the laws of República Federativa do Brasil, under the Brazilian identification number CNPJ/MF 01.637.895/0001-32, with headquarters at Praça Professor José Lannes, no. 40, 9<sup>th</sup> floor, in the capital of the State of São Paulo ("Votorantim Ceimentos"), hereby, on its behalf and on behalf of the entities below mentioned, informs the following:

- On February 3, 2010, in an off-market transaction, Votorantim Cimentos acquired 116,089,705 shares representing 17.28% of the share capital and voting rights of CIMPOR – Cimentos de Portugal, SGPS, S.A. ("CIMPOR").
- 2. On the same day, Votorantim Cimentos celebrated a shareholders' agreement with Caixa Geral de Depósitos, S.A. ("CGD"), an entity holding directly 64,454,995 shares representing 9.59% of the share capital and voting rights of CIMPOR, and indirectly, 271,664 shares representing 0.04% of the share capital and voting rights of CIMPOR, all of which imputable to the latter under article 20 of CMVM as announced to the market.
- 3. In result of the above mentioned a participation of 26.91% of the share capital and voting rights of CIMPOR, corresponding to 180,816,364 shares is imputable to Votorantim Cimentos.
- 4. Votorantim Cimentos is directly controlled by Votorantim Industrial S.A.<sup>1</sup> and by Votorantim Participações S.A.<sup>2</sup>, which fully holds Votorantim Industrial S.A. and is directly controlled by Hejoassu Administração S.A.<sup>3</sup>, to which, therefore, the above mentioned participation is imputable."
